On the one hand, the **Universidad Nacional de Córdoba**, domiciled at Av. Raúl Haya de la Torre s/n, 2o. Piso, Pabellón Argentina, Ciudad Universitaria, City of Córdoba, Argentina, represented herein by its Rector, Mgter. Jhon Darío Boretto,

On the other hand, **LEPL – Ivane Javakhishvili Tbilisi State University**, with registered office at 1, Iliá Tchavtchavadze Avenue, Tbilisi 0179, Georgia, represented by its Rector, Prof. Dr. Jaba Samushia,

Preamble

To advance cross-cultural understanding, academic excellence, and international research and development; and to expand educational opportunities for students, faculty and staff, **LEPL – Ivane Javakhishvili Tbilisi State University** (www.tsu.ge) and **the Universidad Nacional de Córdoba** hereinafter referred to as the Parties, enter into this Memorandum of Understanding according to the terms and conditions that follow.

I. Purpose and Implementation

1. This Memorandum of Understanding acknowledges a mutual interest in cooperating to achieve shared objectives expressed herein.
2. This Memorandum of Understanding is not a legally binding document. It does not define a legal relationship between the parties and does not contain legally enforceable promises. Rather, it outlines the agreement the parties have reached, its objectives and its expectations.
3. To carry out activities of this Memorandum of Understanding, the parties will develop and put forth in writing a detailed agreement that includes financial stipulations.

II. Content

1. Under this Memorandum of Understanding, the two parties agree to foster to their mutual benefit
 - research collaboration
 - Student exchange
 - Academic staff exchange
 - Joint educational programs
2. Other areas for collaboration, not explicitly mentioned above, may be agreed upon by mutual consent of the Parties.

III. Good faith and mutual cooperation

1. In case of disputes and/or differences of opinion, the parties will try to resolve them amicably without recourse to other instances, taking into account the cooperative nature of this agreement.

IV. Commencement and Termination

This Memorandum of Understanding is effective immediately upon signature completion by the Parties. It remains effective for 5 (five) years, subject to revision or modification accepted mutually by the signing Parties.

Each Party shall sign two original copies of this Memorandum of Understanding, one of which shall be kept by LEPL – Ivane Javakhishvili Tbilisi State University and the other by Universidad Nacional de Córdoba.
