

## Memorandum of Understanding

between

**University of Greenwich**

and

**National University of Cordoba**

The University of Greenwich, a charity and a company limited by guarantee, whose registered address is Old Royal Naval College, Park Row, Greenwich, London, SE10 9LS, United Kingdom (“Greenwich”) and National University of Cordoba, whose registered address is Av. Felix Marrone 746. Ciudad Universitaria (“UNC”) (together, the “Parties”), recognising the benefits to their respective institutions from the establishment of international links, enter into this Memorandum of Understanding (“MoU”). The aims of this MoU are to promote academic and educational exchange between the two Parties and to develop a collaborative relationship more fully set out in Clause 1 herein. The MoU is specific to the (Faculty of Engineering and Science) of University of Greenwich and the (Faculty of Agronomy Science) of National University of Cordoba.

### 1. **PURPOSE**

Both Parties agree to develop the following collaborative activities in academic and educational areas on a basis of reciprocity.

- (1) Exchange of information and materials that are of mutual interest;
- (2) Exchange of scientific and pedagogical staff and students;
- (3) Realisation of joint research;
- (4) Conduct of joint lectures, seminars and conferences, including distance ones;
- (5) Preparation of joint scientific publications and exchanging of research results.

2. This MoU addresses the basic working relationship of the Parties but is non-binding and leaves for later agreement the more precise terms that will constitute the substance of the collaboration.

3. This Memorandum shall be officially executed in English. Any translation of this Memorandum shall be subsidiary to the English version hereof in the event of misinterpretation or dispute as to its meaning.

### 4. **FUNDING**

The Parties shall attempt to secure their own reasonable funding to allow for the

successful completion of the activities described herein. Both Parties, however, expressly acknowledge that the activities under this MoU shall be subject to the availability of appropriate funds and personnel of each Party, or the acquisition of other sources of funding. Neither Party shall be liable to the other for any expenses the other Party incurs in performance of this MoU and related activities.

#### **5. RELATIONSHIP OF THE PARTIES**

Nothing in this MoU or elsewhere shall be construed as establishing a contract or a partnership (or any other legally binding commitment) and neither Party shall hold itself out to be the agent or representative of the other. This MoU does not create any right enforceable by any person who is not a Party to it ('Third Party') under the Contracts (Rights of Third Parties) Act 1999 of England and Wales or any other applicable law.

#### **6. PUBLICITY**

Should the name or logo of either Party be used in marketing or publicity material then the approval of each Party must be obtained prior to publication and the content of text in the material agreed. Each Party will provide to the other current prospectuses, brochures, leaflets or other materials as appropriate. Supply of these materials may be made electronically.

#### **7. AGREEMENTS**

In order to foster the successful implementation of this MoU, the Parties agree to the following terms and conditions:

- i. Each Party pledges in good faith to go forward with this MoU and to further its goals and purposes, subject to available funding.
- ii. Either Party may unilaterally withdraw at any time from this MoU by writing to the other Party, giving 28 days' notice of their intention to do so.
- iii. By mutual agreement, which may be either formal or informal, the Parties may modify the list of intended activities set out in Clause 1 above and/or determine the practical manner by which the goals, purposes and activities of this MoU will be accomplished. However, any modification to any other written part of this MoU must be made in writing and signed by both Parties.
- iv. Each Party understands that the other's participation in this MoU does not constitute an endorsement, express or implied of (a) any policy advocated by the other Party; or (b) any goods or services offered or sold by the other Party.
- v. National University of Cordoba shall maintain full right, title and interest in any intellectual property right, including any copyright or trademark, in any work product developed solely by National University of Cordoba under this MoU. Greenwich shall maintain full right, title and interest in any intellectual property right, including any copyright or trademark, in any work product developed solely by Greenwich under this MoU. Ownership of any intellectual property developed collaboratively by the Parties will be discussed separately and will be covered by a separate agreement.
- vi. To comply with all applicable UK and EU data protection, anti-corruption, anti-bribery, and local employment laws, as well as any other applicable legislation,

laws and regulations in connection with their performance under this MoU, (including that relating to import and export control, transportation of hazardous materials, anti-money laundering, and tax laws).

**8. PRIMARY CONTACTS**

The Parties intend that the work under this MoU shall be carried out efficiently and effectively. To that end, the Parties intend to designate individuals that will serve as primary contacts between the Parties.

**9. TERM AND TERMINATION**

Unless extended by a written agreement executed by both Parties, or terminated in accordance with Clause 7.ii above, this MoU shall terminate exactly two (2) years from the date upon which this MoU becomes fully executed by all signatories listed below.
